Please turn in your booth registration form by **Friday, April 10th** to reserve your space at the 2009 Super Summer Kids Activity Fair.

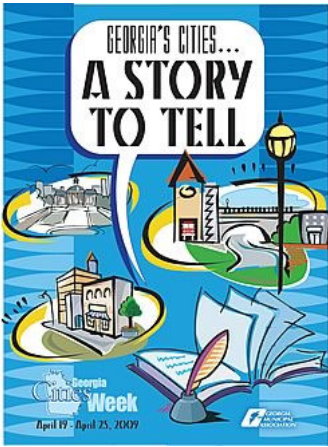
Alternate advertising opportunities are also available during this event in lieu of or in addition to booth spaces. Sponsorships opportunities or goodie bag insert opportunities are available.
