

The 67th Annual Downtown Monroe Christmas Parade will take on a new look for 2020.

Welcome to our first Christmas Parade in Place!

This year parade participants will line Broad Street along the usual parade route and will remain in place while spectators will walk the parade route. The event will officially begin at 6:30 pm and end at 8:00 pm. The new layout will give participants the opportunity to interact with spectators and really show off your creativity with floats, decorating of vehicles and costumes. We can't wait to see what you come up with to wow our community and make the 2020 Parade in Place one to remember!

There will be some important factors to note. Arrival of participants can begin at 4:00 pm. (Details will be given at the mandatory meeting.) All vehicles and participants must be parked in their assigned parade location by 5:30 for judging. Entries must still be mobile and contained to a vehicle, truck or trailer. Participants may stand around entry during the time spectators will viewing but must be able to disperse quickly when the event ends. Walking groups, bands, dance groups, chorus groups etc. are still allowed, but must be able to disperse quickly when the event ends. All entries and participants must remain in the assigned location for the duration of the event. Exit instructions will be given at the mandatory meeting.

General Information, Requirements and Fees Please keep this information, do not turn in with parade application.

- 1. All entries must be one float or one vehicle only. These are called units. Any applicant that has more than one unit must pay the additional unit charge per unit. (i.e. a float pulled by a truck, plus an accompanying car would be considered two units and would pay one entry fee PLUS one "Additional Unit Fee) *See fee schedule below.
- All entries MUST be decorated according to the parade theme, "Christmas Outside of the Box".
 In addition, entries are encouraged to illuminate their entry using batteries, wiring, generators, AC converters, etc.
- 3. Please plan to arrive at your assigned location NO LATER THAN 5:30 p.m. on the day of the parade.
- 4. The Monroe Downtown Development Authority reserves the right to refuse participation to any entry at its sole discretion, including but not limited to any entry containing political and social statements or issues.
- 5. To avoid the possibility of injury to spectators or participants, participants are not allowed to throw candy or other items from any float or vehicle in the parade, but this year, you may hand out candy or fliers to spectators. This policy will be strictly enforced. Participants must stay within their assigned location for the duration the parade in place. (5:30-8:00)
- 6. Animals participating in the parade must be harnessed or leashed at all times. Entries are responsible for the removal of any animal waste made throughout the parade in place and ensure location is clean prior to leaving
- 7. Vehicles:
 - Only individuals 18 years of age and older will be allowed to drive automobiles, trucks, floats, tractors or motorcycles
 - All drivers must have personal liability insurance and must submit a copy of insurance with parade application.
 - No sitting on the sides of pick-up trucks, or standing in the bed of pick-up trucks while vehicles are traveling to & from parade in place location.
 - Drivers will not speed, squeal/spin tires, or drive towards spectators while vehicles are traveling to & from parade in place location.
- 8. No Santa can be used on any float or entry, live or mannequin. The official Santa will arrive at the end of the parade.
- 9. Children that are riding bicycles must have adult supervision in front, back and sides of formation, and be wearing a helmet while riding.
- 10. Only FLOATS will be judged. For judging criteria see page 5.

Failure to follow these guidelines will result in removal from the parade.

Judging

Only floats will be judged. Judging begins at 5:30 pm. Floats must be in assigned location ready to be judged. Awards will be given for the following:

Mayor's Award-best overall float from a non-profit.

Chairman's Award-best overall float from business

Superintendent Award —best overall float from a school

An honorable mention in each category will be awarded. In order to be judged, floats must be lined up by 5:30 pm.
